3. Bidding will be conducted through the International Competitive Bidding procedure specified in the Public Procurement Law and Circulars, and is open to all Bidders from Eligible Source Countries as defined in the Guidelines.
4. Interested eligible bidders may obtain further information from Procurement Unit, DABS, and inspect the bidding documents at the address given below from 8:00 hrs to 16:00 hrs on any working day from Saturday to Wednesday.
